Arkansas	"In accordance with Arkansas law, a notice filing for a covered securities offering under section 18(b)(4)(F) of the Securities Act of 1933, 15 U.S.C. § 77r(b)(4)(F) shall be renewed on or before the anniversary date of the initial notice filing, or the notice filing shall terminate. A terminated filing cannot be renewed. Instead, a new filing must be made. If a terminated filing is renewed through EFD, the renewal is not effective. In addition, the \$100 filing fee paid for the renewal of a terminated filing is nonrefundable and cannot be applied to the fee associated with a new filing. "
